

Regulations for Social Visiting
FCI Allenwood

- All visits must be prearranged and verified through the inmate's unit team prior to being scheduled a visit.
- Visits will be limited to three hours.
- Each inmate is authorized two visitors. This includes adults and children.
- Visitors are not authorized to arrive and/or enter the FCC Allenwood Complex earlier than 30 minutes prior to the start of visitation. It is expected that all vehicles follow posted speed limit signs, safety signs and cone directions when entering and leaving the complex.
- All visitors must complete a medical screening and temperature check prior to entrance to the facility. Visitors who refuse, fail to provide acceptable answers to the questions, or are symptomatic/feverish, will not be permitted entrance onto the complex.
- Should multiple visitors arrive in the same vehicle, and one or more persons inside the vehicle are unable to process through the screening site (fever, symptoms, or refusal), the entire vehicle will not be permitted entrance onto the complex.
- Visitors and inmates are required to wear face coverings at all times. Visitors will only remove face coverings, briefly, to allow staff to positively identify individuals. Face Coverings will not be permitted that contain political and/or offensive statements as determined by staff. Face coverings must be in compliance with CDC guidelines. No "gaiter" style face coverings, bandanas, and/or masks with vents are authorized.
- Upon entry into FCI Allenwood visitors will be given an antimicrobial paging transmitter and Title 18 form. Visitors will take these items and exit the lobby to complete the Title 18 forms in your vehicle. The Front Lobby Officer will page the transmitter when it is time for you to be processed in.
- All visits will be completely **non-contact**. This includes no embracing or kissing at the beginning nor end of a visit. This also includes the embracing or holding of children.
- Social distancing of six feet must be maintained between visiting groups and inmates at all times. Chairs in the visiting room cannot be moved.
- There will be no food or beverages inside the visiting room, with the exception of baby formula and life saving medications.
- There will be no vending machines available for use. Therefore, no currency (money) will be allowed inside the visiting room.
- The photography program is suspended. Inmates and visitors will not be permitted to take photos while visiting.
- Board games, decks of cards, etc., will not be available for use during visitation. The children's play area will not be available for use.
